Notarial Services Request and Payment Form

Notarial services are legal acts which allow a written record to be used for official or legal purposes. This includes using a document in a court of law.

We recommend reading the information at <u>Notarial services | Smartraveller</u> and <u>Notarial services overseas | Smartraveller</u> to assist you in determining which service you require.

The Australian Consulate-General in Geneva offers the following services by mail:

1. Legalisations (Authentications and Apostilles)

The process of authenticating a document means verifying the signature, stamp and/or seal which appears on an original document and making a statement on the document to that effect. This process does not certify the contents of the document or imply that the contents are correct.

We can only authenticate public documents:

- Documents issued directly by an Australian government agency or official, such as a birth certificate.
- Documents that have been notarised or certified by an Australian notary public.

2. Certified Copies

Certifying a copy is **NOT** the same as legalising a document. Only an authentication or apostille can provide confirmation of the origin of the document.

We can only produce certified copies of Australian documents that are required for use in Australia. Local providers, such as notary publics, can certify other documents.

To obtain an apostille, authentication or certified copy of/on an original document through the mail, please provide the following:

- 1. Completed Notarial Services Request form (below)
- 2. Completed Credit Card authorisation form (below)
- 3. Your original documents
- 4. An A4-sized return envelope clearly marked with your full name and address

Documents that are mailed without the above information/instructions and/or the correct payment cannot be processed. We recommend using a postal service that allows you to track delivery of documents. Documents will be processed and returned within two business days.
